

Radiation oncology and radiopharmaceuticals to be managed through the Oncology Value Management program starting Sept. 1

Radiation oncology services, including proton beam therapy, and radiopharmaceuticals will be managed through the Oncology Value Management program, administered by OncoHealth, for dates of service on or after Sept. 1, 2026. This expansion of the Oncology Value Management program complements OncoHealth's management of prior authorization requests for most oncology medical benefit and pharmacy benefit drugs.

Affected members

The Oncology Value Management program, including the change outlined above, applies to the following members when services are received in Michigan or in other states:

- Blue Cross Blue Shield of Michigan and Blue Care Network commercial
 - Most fully insured members — **Exception:** MESSA members don't have requirements under the Oncology Value Management program.
 - Most self-funded groups — To determine which groups have opted out of the Oncology Value Management program, see the [Oncology Value Management program opt-out list for self-funded groups](#).

Note: Carelon will continue to manage medical oncology drugs and radiation oncology services for UAW Retiree Medical Benefits Trust members with Blue Cross commercial plans.

- All Medicare Plus Blue and BCN Advantage members

The following radiopharmaceutical procedure codes will be managed by OncoHealth under the Oncology Value Management program for dates of service on or after Sept. 1, 2026.

These drugs require prior authorization for all members, whether they receive services in Michigan or outside of Michigan.

Site-of-care requirements will also apply for commercial members who receive treatment in Michigan. Members who start therapy before Sept. 1, 2026, and continue therapy after Sept. 1, 2026, will be able to continue to receive treatment at their current place of service for one year. If the member's therapy continues beyond Aug. 31, 2027, site-of-care requirements will apply for dates of service on or after Sept. 1, 2027.

How to submit prior authorization requests

Starting Sept. 1, 2026, submit prior authorization requests to OncoHealth through the OncoHealth OneUM portal or by calling OncoHealth at 1-888-916-2616.

Additional information

As a reminder, radiation oncology services and radiopharmaceuticals are managed as follows for dates of service before Sept. 1, 2026:

- EviCore by Evernorth® for Blue Cross commercial fully insured and individual members, BCN commercial members, Medicare Plus Blue members and BCN Advantage members.
- Carelon Medical Benefits Management for some Blue Cross commercial members who have coverage through self-funded groups.
